- A discharged battery completely recharges in 24 hours, via a fully automatic solid-state, two-rate charger.



MOUNTING

- UL listed for factory or field installation. Suitable for damp location.
- Can be mounted inside, on top, or remote from the fixture.*
- Designed to be used in both switched and unswitched fixtures.
- * When battery packs are remote mounted, the remote distance cannot exceed 1/2 of the distance from ballast to lamp specified by the AC ballast manufacturer. The maximum allowable remote mounting distance is 50 feet.
